CONDITIONS

The September 1982 meeting of the National Executive agreed to the concept of a Meritorious Service Medal as an honour over and above Life Membership. It is to be awarded only to those already holding Life Membership, who have had 30 years continuous membership and who have given 25 years outstanding service.

As the recommendation for Life Membership has already been endorsed by a general meeting of the Sub-Branch, the recommendation for the Meritorious Service Medal should be confined to a special meeting of the Sub-Branch Committee.

The success of an application not only depends on the information contained in the application form, but the quality and quantity of citations and references attached to the application form.

Completed application forms, together with supporting citations and letters of recommendation are to be forwarded to the CEO RSL-SA Branch, ANZAC House, Victoria Drive, ADELAIDE SA 5000 in an envelope marked 'Confidential'.

Presentation of Meritorious Service Medals will be made at the Sub-Branch by either the State President, CEO or their representative, with a formal representation at the next Sub-Branch Conference.

The Meritorious Service Medal comprises:-

- A medal which is worn on the right breast whenever Service Medals, decorations and awards are worn;
- A lapel badge in the form of a Life Member's badge surrounded by a laurel wreath which is work by recipients in place of their previously awarded Life Membership lapel badge; and
- A certificate.
