2020 ANZAC Appeal Order Form



APPEAL PURPOSE: The ANZAC Appeal is a major fundraising activity to provide advocacy services, wellbeing programs and assistance to veterans and families.

CHARITABLE COLLECTION: ANZAC Appeal merchandise is purchased by RSL SA and supplied to Sub-Branches and organisations at no charge. The public expect that their donations are raised for, and paid to, the ANZAC Appeal, Charity Licence No. CCP3271.

ACCOUNTABILITY: RSL SA is required to exhibit proper diligence and accountability in all aspects of this appeal. Those controls are also incumbent on Sub-Branches and collectors as agents. Stock will be recorded out; surplus stock is to be returned to RSL SA for monitoring; and donated funds forwarded for the charity. Surplus stock may be kept but must be paid for in the total amount remitted.

SUPPLIES: Some Sub-Branches over-order quantities then return significant amounts. This may have limited us from supplying to others that could have raised funds if they had received the stock. Check for appeal items already stored within the Sub-Branch and place an order only for what will feasibly sell. Item quantities are not limitless and excessive orders may be adjusted.

DELIVERY COSTS: To keep our costs manageable we request your assistance with collecting orders from State Branch if possible. To ensure your order is ready get our confirmation that it is available for collection.

- Cash may be brought to RSL SA State Branch office. No bulk coins, please convert coins to notes to assist processing.
